AGREEMENT TO RECEIVE COMMUNICATIONS ELECTRONICALLY

The Dog Obedience Club of Greenville (DOCG) is required to obtain your consent before delivering communications electronically. You understand that your consent also permits the DOCG to electronically deliver to you, initially and on an ongoing basis, all future communications relating to the DOCG.

Consent to receive disclosures electronically and scope of consent

By checking the "I AGREE" box, you are affirmatively consenting to receive DOCG communications in electronic format. Additionally, by agreeing to this, the DOCG will not send any paper communications to you until your consent is withdrawn in writing. Your consent to receive electronic communications includes, but is not limited to:

- Annual membership notifications
- Updates/Addendums to the DOCG By-Laws
- Updates/Addendums to the DOCG Constitution
- Announcements regarding DOCG training days and seminars
- And all other information relating to the DOCG, i.e., Financial Reports, etc.

DOCG method of providing communications to you in electronic form

All communication that the DOCG provides to you in electronic format will be provided via email, through access to the DOCG website, or as a downloadable .pdf or .doc file.

Valid email address

As a DOCG member, you agree to provide the club with a valid, active email address. You agree to promptly notify the DOCG Membership Chair, as well as the DOCG Treasurer of any change to your email address. The Membership Chair will maintain the club's master database and will ensure the DOCG Members Google-Groups administrator is informed of these changes.

Right to receive paper communications

The DOCG will not send you a hard copy of any communication unless requested. If such a request is made, a nominal fee will be charged for copying and postage. This fee will fluctuate depending on the items to be copied and mailed. You may also obtain a hard copy of any electronic communication by printing it yourself.
